You should retain all the documents, books and records that form the basis of your income and deductions. This information may be necessary to prove the accuracy and completeness of the returns to a taxing authority. Because you have final responsibility, you should carefully review before you sign and file the returns.

Invoices are due and payable upon presentation. Any other services, including tax planning or assistance with taxing authority correspondence, are not included in this engagement and will be billed separately.

The filing deadline is March 17, 2025 for S Corporation, Multi-member LLC, and Partnership returns. Information needed to complete the return should be provided to our office no later than February 5, 2025. Returns may be extended at our discretion, and therefore we encourage you to provide the information to our office as soon as possible to allow adequate time for preparation. If an extension of time is required, any tax estimated to be due must be paid by March 17, 2025, or you may be subject to interest and late payment penalties.
